CRITICAL MINERALS APPG CONVENES INDUSTRY MEETING

On 29 October, the All-Party Parliamentary Group (APPG) for Critical Minerals convened a meeting on 'Making Critical Minerals Work for the United Kingdom'.

Hosted at the Houses of Parliament ahead of the upcoming G7 summit and updated UK Critical Minerals Strategy, this forum was an opportunity to bring over 50 industry stakeholders together to discuss priority areas of change.

Chair of the APPG Noah Law MP was joined by Vice Chair Baroness Northover and Officer Perran Moon MP to deliver welcoming remarks. They then opened the floor to hear insights from a select group of industry experts from Wood Mackenzie, Ionic Technologies, Fasken, DEScycle, Cornwall Resources, Britainnia Refined Metals, and Anglo American.

After the roundtable discussion, Noah opened the floor to discussion from the audience.

CHINA ANNOUNCES FURTHER EXPORT CONTROLS

On 9 October, China's Ministry of Commerce expanded export controls to include 5 new elements (holmium, erbium, thulium, europium, ytterbium), with new rules targeting semiconductor and defence users.

The move came just 2 days after U.S. lawmakers called for broader bans on chipmaking exports to China, and just weeks before a planned meeting between Presidents Donald Trump and Xi Jinping in South Korea.

Notably, foreign producers using Chinese materials or tech must now comply with Beijing's export rules outside China, and for transactions that don't involve Chinese companies. It remains unclear how China intends to enforce this.

The restrictions will take effect on November 8, but markets are already reacting. Chinese and U.S. rare earths stocks surged yesterday as companies brace for tighter supply.





TRUMP & XI MEET FOR TRADE SUMMIT IN SOUTH KOREA

On 30 October, US President Donald Trump and Chinese President Xi Jinping met for the first time in 6 years in a highly anticipated summit aimed at deescalating trade tensions between the world's two largest economies.

Trump described the talks as "amazing", while Beijing reported that the two parties have reached a consensus to resolve "major trade issues".

Tensions are high since Trump imposed new tariffs on China, prompting retaliations from Beijing earlier this month including additional export controls on critical minerals. While a truce was brokered in May, no agreement was formalised and the future of trade between the two nations remains uncertain.

A trade deal has yet to be signed but in a crucial move, China has agreed to suspend its export restrictions on rare earths.





TRUMP TOURS ASIA TOUR & SIGNS JAPAN AGREEMENT

U.S. President Donald Trump concluded his 6-day tour of Asia this week, marking his most ambitious diplomatic push in the region since returning to office for his second term.

Spanning Malaysia, Japan and South Korea, the tour aimed to secure new trade frameworks, strengthen energy and defence partnerships, and recalibrate relations with Beijing.

In the second leg of his tour, Trump travelled to Japan to meet with the country's first female prime minister, Sanae Takaichi. The two leaders signed a joint Framework for Securing Critical Minerals and Rare Earths through Mining and Processing.

The deal includes next-generation nuclear power reactors, as Tokyo seeks a way to re-enter the export market for its nuclear technology and reduce Chinese dominance over key electronic components.





IEA PUBLISHES GLOBAL OUTLOOK 2025

In May 2025, the International Energy Agency (IEA) published its Global Critical Minerals Outlook 2025, including a detailed assessment of the latest market and investment trends, along with their implications for critical minerals security.

The report provides the most comprehensive snapshot of recent industry developments from 2024 and early 2025. It also offers medium- and long-term projections for the supply and demand of key energy minerals, taking into account the latest policy and technological developments.

UK & GREENLAND RESUME TRADE TALKS

On 3 October, the UK Department for Business and Trade (DBT) announced that UK Government has resumed trade talks with Greenland.

Negotiations on UK-Greenland trade deal are set to slash tariffs on over £70m of seafood imports, deepen strategic partnership on delivering climate security in the Arctic and North Atlantic, and strengthening cooperation on critical minerals.

UK firms currently hold a third of mining licences in Greenland. "Developing these supply chains responsibly together with Greenland and our partners will safeguard strategically important industries, strengthen British and European long-term economic security and reduce dependence on volatile global markets," said DBT in an official press release.





INDIA & UK LAUNCH CRITICAL MINERALS OBSERVATORY

On 9 October, the UK and India launched a new Critical Minerals Processing and Downstream Collaboration Guild during the Prime Minister's first official visit to India.

PM Starmer was accompanied by a 125-member delegation of business, academic, and cultural leaders, including 10 UK companies in the battery supply chain such as Altilium Clean Technology and Cornish Lithium Plc.

Starmer's discussions with Indian PM Narendra Modi focused on strengthening cooperation in critical minerals, a key issue for energy and emerging technologies. Following the talks, the two leaders also agreed to launch Phase II of the UK-India Critical Minerals Supply Chain Observatory, aimed at ensuring responsible access to critical resources.





UK & FRANCE TO FORMALISE COOPERATION

At the 3rd UK-France Critical Minerals Policy Exchange in Paris during LME Week, the UK Foreign, Commonwealth and Development Office (FCDO) and France's Ministry for Foreign Affairs has signed a Letter of Intent formalising bilateral cooperation on Critical Minerals.

"This is a major step forward to strengthen our collective resilience and economic security, following the UK-France Summit Leaders' Declaration," said an official statement on LinkedIn by the British Embassy in Paris.

The meeting also marked the signature of a Joint Statement between UK Export Finance (UKEF) and Bpifrance Assurance on collaboration on financing for critical minerals projects.





ORION PARTNERS WITH US FDC ON MINERALS FUND

ON 23 October, Orion Resource Partners LP, a leading global investment firm specialising in metals and minerals, announced the formation of the Orion Critical Mineral Consortium (Orion CMC).

Orion CMC is a mission-driven consortium designed to support the United States and its allied and partner nations to develop secure, responsible, and resilient critical mineral supply chains. Created in partnership with the U.S. International Development Finance Corporation (DFC), the Orion CMC aims to bring together some of the world's leading metals and mining investors and operators, creating a multi-billion platform for critical minerals investments.

The Consortium's combined expertise will invest in and develop critical minerals in emerging and other market jurisdictions, manage offtake, develop domestic processing and integrate and scale cost-effective tech solutions.

US AND AUSTRALIA SIGN \$2B CRITICAL MINERALS DEAL

On 21 October, U.S. President Donald Trump and Australian Prime Minister Anthony Albanese signed a new critical minerals agreement aimed at strengthening supply chain resilience and supporting new mining and processing projects across both countries.

Under the agreement, the U.S. and Australia will each invest \$1 billion over the next 6 months in critical minerals projects. The deal also includes plans to establish a minimum price floor for certain materials, intended to promote long-term investment stability in the sector.

PM Albanese described the partnership as part of an \$8.5 billion project pipeline, with both governments outlining that investments will target deposits valued at ~\$53 billion. Details on specific projects have not yet been released.

DESNZ IDENTIFIES CLEAN ENERGY MISSION AREAS

On 6 October, the Department for Energy Security and Net Zero (DESNZ) published its Clean Energy Superpower Mission areas of research interest - and critical minerals is one of them.

The new publication sets out how the UK can accelerate the transition to Net Zero through innovation and R&D. In section 3.2.1.1. Circular Economy, DESNZ emphasises the importance of moving away from the traditional 'take, make, dispose' model toward systems that eliminate waste, maximise resource efficiency, and close material loops.

By including critical minerals in this mission statement, DESNZ highlights the central role they play in the growth of the circular economy. Transforming the way we use and reuse resources underpins the UK's clean energy ambitions while also strengthening national security, reducing import dependence, and boosting supply resilience.





PLC JOINS THE ASSOCIATION

CMA (UK) is delighted to welcome our newest member EnergyPathways plc to the Association.

EnergyPathways Plc (EPP) is developing low-emissions energy solutions to satisfy the UK's growing demand for home-grown clean energy as it transitions to Net Zero.

EPP's flagship project, the Marran Energy Storage Hub (MESH), will deliver a secure and flexible supply of low-carbon, low-cost energy through large-scale gas and green hydrogen storage off the coast of Lancashire. As an energy infrastructure project, the facility will be equivalent in size to UK's largest gas storage facility.

With demand for energy storage only continuing to rise, EPP's strategic location positions it to play a key role in regional growth and UK energy security.

UK Government has made the circular economy (CE) a national priority, with a new strategy due by the end of this year. The UK Ministry of Defense also published a concept note detailing how CE would deliver benefits for defense.

CORNISH LITHIUM PRODUCES LITHIUM HYDROXIDE

On 24 October, Cornish Lithium plc announced that it has become the first company in the UK to produce lithium hydroxide monohydrate (LHM), a key compound for making the lithium-ion batteries found in electric vehicles, grid scale battery storage, and batteries for consumer electronics.

Based in Cornwall, Cornish Lithium has repurposed a former china clay quarry and used patented low-carbon processing technology to produce LHM extracted from Cornish granite.

"We can test every single stage of it on an industrial scale," said founder and executive chairman Jeremy Wrathall to BBC News. "That's why it is such an important day for us."

Cornish Lithium plans to build a full-size lithium processing and refining plant with an annual capacity of up to 10,000 tonnes. It could be in full-scale production by 2029, creating 300 jobs and injecting £800m into the UK economy.





NORTHERN LITHIUM PARTNERS FOR UK PRODUCTION

On 15 October, Northern Lithium announced an official partnership with Kurita and Evove to deliver commercial production of lithium carbonate in the UK from 2027 from lithium brines in County Durham, North East of England.

This tripartite partnership secures key steps towards delivering long-term production, using Evove's advanced membrane-based Direct Lithium Extraction (DLE) technology and Kurita's renowned water treatment solutions expertise.

Detailed design engineering is underway, with delivery of initial commercial production of 500 tonnes per annum (tpa) expected by the end of 2027. Northern Lithium has set targets to scale this initial capacity to 20,000+ tpa.

It is forecast that the UK demand alone could be in excess of 80,000 tpa by 2035, with Northern Lithium potentially capable of supplying 25% of that domestic requirement.







ZWS PUBLISHES INTERACTIVE SYSTEMS MAPS

On 20 October, Zero Waste Scotland (ZWS) published Systems Mapping of Scotland's Built Environment and Energy Infrastructure Sectors to illustrate the factors influencing circular economy principles and practices.

The systems maps show how policy, market dynamics, supply chains, and resource flows interact across the sectors, helping users identify opportunities for greater resource efficiency and impact mitigation efforts.

The maps also highlight where barriers and opportunities lie for enabling change, and how connected they are to understand influencing consequence. They focus on four strategies: circular design, lifetime extension, alternative business models, and recycled materials.

ZWS has also published a technical report and summary providing further context and analysis of their findings.

MINVIRO & PROJECT BLUE ON COPPER SOURCING

Minviro's recent collaboration with Project Blue brought their life cycle assessment (LCA) expertise and Project Blue's economic foresight to explore the environmental and financial dimensions of copper sourcing.

Their research revealed that recycled copper makes up 35-40% of global supply, and when produced efficiently, can reduce energy use by up to 90% and CO_2 emissions by up to 80% compared to primary copper.

However, the 'smart copper strategy' is "not about choosing the cheapest or the greenest option, but about integrating both perspectives to make data-driven, future-ready sourcing decisions." Minviro and Project Blue are bridging environmental impact and economic intelligence to help businesses navigate the material transition, from mine to market.





CMA (UK) ATTENDS CONSERVATIVE PARTY CONFERENCE

CRL PUBLISHES STANDOUT DRILLING RESULTS

On 13 October, Cornwall Resources Limited (CRL) announced standout drillhole results from the first borehole of its ongoing drilling campaign at the Redmoor tungsten-tin-copper project.

The laboratory assay results reinforce Redmoor's status as Europe's highest grade, undeveloped, tungsten resources, and one of the highest grade deposits globally.

Charles Manners, Executive Chairman of CRL's parent company Strategic Minerals Plc, said: "It is in the Board's opinion that Redmoor's value has gone unrecognised, and our intention is to further progress the project and highlight its merits within a global context.

With tungsten prices rising significantly this year, and a global push to secure access to critical and strategic minerals, Redmoor is well placed as a world leading asset."

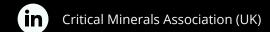
