CRITICAL MINERALS A DEFINING TOPIC AT DAVOS

From 19 to 23 January, the World Economic Forum held its Annual Meeting in Davos, welcoming global leaders to discuss critical issues and address key economic challenges.

Critical minerals was a defining topic at this year's forum, with discussions centering around the increasing 'scramble' for raw materials needed for the energy transition and AI revolution, with many state leaders such as Canadian Prime Minister Mark Carney advocating for international cooperation on diversifying and securing supply chains amid rising protectionism and geopolitical shocks.

Discussions also underscored the impact of this scramble on emerging economies and resource-rich nations, while industry leaders urged policymakers to urgently implement long-term industrial strategy.

UK LAUNCHES RARE EARTHS MAGNET RECYCLING FACILITY

On 15 January, CMA (UK) representatives Kirsty Benham, Becca Kirk, and Enzo Granzella visited Tyseley Energy Park for the launch of the UKRI-funded Rare Earth Magnet Recycling Facility. The facility was opened by the Minister for Industry Chris McDonald MP, and welcomed over 100 attendees from across industry, academia, and government.

This world-leading facility is the first of its kind in the UK and reintroduces sintered magnet production for the first time in more than 25 years, supporting the development of technologies central to the UK's Modern Industrial Strategy.

Congratulations to the University of Birmingham, Innovate UK, Professor Allan Walton and his team at HyProMag Ltd, as well as their parent company Mkango Resources Ltd, for this incredible achievement and the successful launch of a landmark facility for the UK's critical minerals sector.

CHINA RARE EARTH EXPORTS SURGE TO 2014 LEVELS

In 2025, China's exports of rare earth elements climbed to about 62,585 metric tons, marking the highest annual total since 2014 despite Beijing imposing export restrictions on rare earths last year.

Following U.S. tariffs in April 2025, the Chinese Ministry of Commerce initially imposed export restrictions on several medium and heavy rare earths and related magnets. The move caused magnet shipments to plunge in April and May, but exports began recovering in June after trade agreements with the U.S. and Europe eased tensions.

Shipments also dipped in December as buyers slowed purchases after stockpiling for the holidays, but remained significantly higher than last year, reflecting growth in global demand even amid geopolitical and trade pressures.

CMA (UK) MODERATES UK- KAZAKH FORUM

On 20 January, our Analyst Enzo Satkuru-Granzella attended a Mining and Critical Minerals discussion organised by the British-Kazakh Society (BKS), Foreign, Commonwealth and Development Office (FCDO), Department for Business and Trade (DBT), and Embassy of Kazakhstan in the UK.

The event together over 50 senior policymakers, industry leaders, and BKS members to examine how the UK-Kazakh strategic partnership is evolving. It was chaired by Rupert Goodman OBE and welcomed speakers such as Ruslan Karabulov (Chargé d'Affaires, Embassy of Kazakhstan in the UK), Her Excellency Sally Axworthy MBE (HM Ambassador to Kazakhstan) and Christopher Allum (UK Export Finance).

Thank you to the organisers for inviting CMA to attend and moderate the Q&A session. We look forward to continuing to support strategic cooperation between the UK and Kazakhstan on securing critical mineral supply chains.

US PROPOSES \$2.5B CRITICAL MINERALS STOCKPILE BILL

On 15 January, U.S. lawmakers introduced bipartisan legislation for a \$2.5b strategic stockpile of critical minerals.

The proposal aims to protect the U.S. economy and national security from supply disruptions and price volatility, while reducing reliance on foreign suppliers.

The stockpile would be managed by an independent board, with minerals sourced from both domestic mining and recycling, stored across the U.S., and sold when necessary to stabilise markets. Profits would be reinvested to keep the reserve self-sustaining, and allied countries could participate by contributing funding.

Lawmakers argue the plan would strengthen domestic production, support clean energy and defence industries, and help to establish a Western alternative to foreign-controlled mineral pricing.

TRUMP SIGNS NEW CRITICAL MINERALS EXECUTIVE ORDER

On 15 January , U.S. President Trump signed the first Executive Order of the year related to critical minerals, titled "Adjusting Imports of Processed Critical Minerals and Their Derivative Products into the United States".

The order places an emphasis on the use of international partnerships to strengthen US mineral security, and is focused on the trade of processed critical minerals. The order identifies price volatility as a fundamental weakness in critical mineral markets - and one that deters private investment, placing the long-term sustainability of U.S. mining, processing, and downstream manufacturing at risk.

The order also underscores mining critical minerals domestically does not safeguard the national security of the U.S. if manufacturers remain dependent on a foreign country for the processing of that mineral.

IONIC RARE EARTHS RECEIVES £12M OFFER FROM UK GOVT

On 27 January, Ionic Rare Earths (IonicRE) announced that their wholly owned subsidiary Ionic Technologies has been provided an Offer in Principle for a £12 million capital grant from the UK Government to support the delivery of a commercial magnet recycling facility in Belfast.

This ground-breaking magnet recycling facility would produce 400 metric tonnes per annum of high purity separated magnet Rare Earth Oxides, utilising Ionic Technologies' patented long-loop recycling technology.

IonicRE is now advancing the remaining financing activities required for the project, with multiple parties appraising investment amid the national drive to deliver a secure and responsible rare earths supply chain for the UK's advanced manufacturing, defence and renewables sectors.

SML RAISES £4M IN FUNDING FOR CORNWALL RESOURCES

Following the success of its matched Shared Prosperity Fund exploration programme at Redmoor, Strategic Minerals plc (SML) has raised £4 million through a placing and share subscription involving new high net-worth and institutional investors.

The funding will be used to advance and accelerate Cornwall Resources Limited's Redmoor tungsten-tin-copper project, Europe's highest-grade undeveloped tungsten resource.

The capital will primarily support further drilling at Redmoor, building on strong 2025 results, with infill drilling aimed at upgrading the JORC Inferred Resource to an Indicated Resource ahead of a mining prefeasibility study.

SML intends to progress the project rapidly into prefeasibility. Additional funding will support team, facilities, and economic activity in Cornwall.

DESCYCLE WINS PRESTIGIOUS EU TECH FUNDING

DEScycle, a UK-based deep tech company developing sustainable ways to recycle metals, has been selected to participate in the SPRIND Tech Metal Transformation Challenge - one of Europe's most selective programmes backing technologies to reshape industrial systems.

"Being chosen reflects the growing belief that circular metals recovery must move beyond marginal efficiency gains and address structural weaknesses in global supply chains," says DEScycle in a statement on LinkedIn.

The programme begins with €1.5 million in funding, with the potential to scale to €6m as companies progress through technical and commercial milestones. It places DEScycle squarely inside a priority European agenda around critical raw materials, industrial resilience, and circular economy.

CMA (UK) AT UKRI BBSRC CIRCULAR ECONOMY EVENT

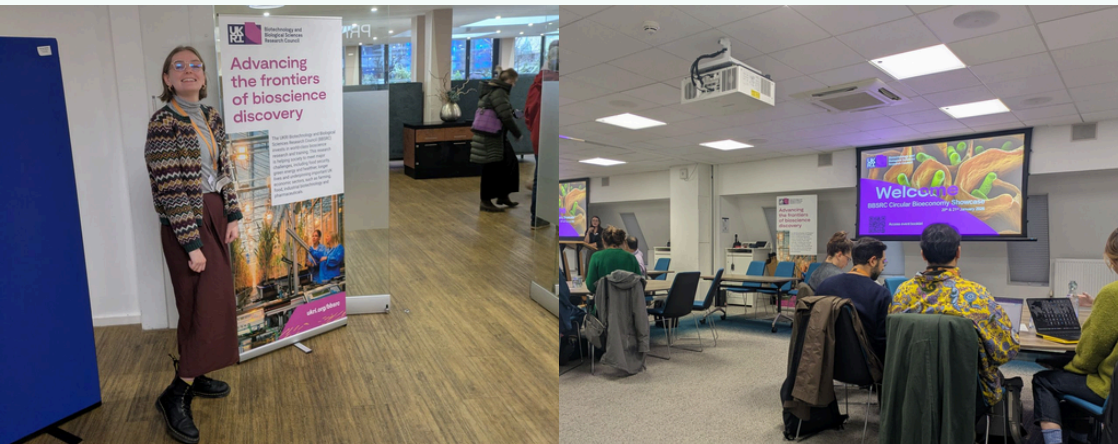

£850K INVESTMENT INTO ABERDEEN MINERALS

On 8 January, Aberdeen Minerals announced a new £850,000 investment into the company from its largest shareholder, London-based Central Asia Metals Plc (CAML).

The investment will fund 'Phase 3' exploration drilling and geophysics at the Arthrath Project area and other activities in Aberdeenshire, North East Scotland, where the company is exploring for nickel, copper and cobalt in partnership with local landowners.

The UK Government's Critical Minerals Strategy (November 2025) recognises nickel and cobalt as critical minerals, and copper as a growth mineral, each being "essential to the UK's economy, national security, and clean energy transition."

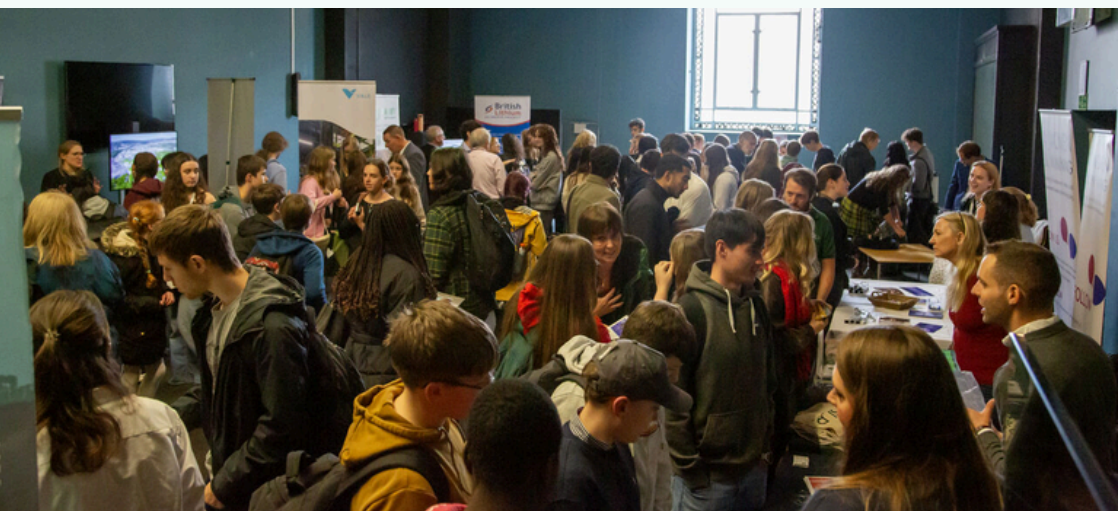



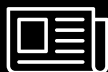
